The condition that the affidavit needs to be prepared in stamp paper and to be notarised is also removed. Instead, the affidavit needs to be prepared in a plain paper and the affidavit duly filled and signed by the bidder needs only to be submitted.

3 The Bidder shall furnish, as part of his Bid, a Bid Security for an amount as detailed in the Quotation Notice. Any bid not accompanied by an acceptable Bid Security shall be rejected by the Tender Inviting Authority as non-responsive.

4 Bid Security shall be in the form of Treasury Fixed Deposit or in the form of Bank guarantee. Bank Guarantee shall be from any Nationalized/ Scheduled Bank/ Kerala Financial Corporation/ District Co-operative Banks, Primary Co-operative Banks, Urban Co-operative Banks or any other forms prescribed in the revised PWD Manual
